#### 3. HOW IS THE PROCESSING OF PERSONAL DATA CARRIED OUT?

#### a) Applicable regulations:

The processing of personal data by IATI CORREDURÍA DE SEGUROS, S.L. is carried out in accordance with Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data (General Data Protection Regulation, GDPR) and in accordance with Organic Law 3/2018 of 5 December on the Protection of Personal Data and Guarantee of Digital Rights (LOPDGDD). Law 34/2002 of 11 July on Information Society Services and Electronic Commerce (LSSI) also applies.

#### b) Purposes of the processing and legitimacy for the processing

#### **PURPOSES:**

Depending on the form you fill in, your data will be used for different purposes. The purposes for which we process your personal data are listed below:

- 1. Dealing with queries about information requests that you can make on your own initiative by contacting IATI CALZADO CORREDURÍA DE SEGUROS, S.L. by means of the contact telephone number, chat or by email.

- 5. Keeping in contact with the insured parties for the correct performance of the insurance policy; this includes the provision of a customer area and an after-sales service.
- 6. Communication of data to third parties in the event of claims (experts, ambulance services, workshops, tow truck services, private transport services, lawyers, solicitors and notaries, doctors, medical centres and hospitals, rehabilitation centres, detectives, group accident agencies (as an indication but not limited to, depending on the claim).
- 7. Communication of data to public administrations, including the Tax Administration, Justice Administration, Social Security and State Security Forces and Corps.
- 8. Comparison of personal data for the purposes of fraud prevention.
- 9. Consultation of solvency and credit files for the purpose of calculating premiums.
- 10. Data may be communicated to third parties when so provided by a regulation of European Union Law or a Law in order to comply with a legal obligation.

## d) What rights can be exercised?

# i) How long do we process your personal data, and how long do we keep it?



IATI CALZADO CORREDURÍA DE SEGUROS, S.L. will process your personal data in general as long as the consent given by you is valid. And specifically:
